MICROSOFT'S RESPONSE TO  
ORDER TO SHOW CAUSE  
REGARDING SUBJECT MATTER  
JURISDICTION

1 On March 25, 2015, Defendant Microsoft Corporation (“Microsoft”) removed this  
2 lawsuit from King County Superior Court to the United States District Court for the Western  
3 District of Washington. (Notice (Dkt. #1).) On April 7, 2015, after granting a motion to  
4 remand in *Williams v. Microsoft Corp.*, Case 2:15-cv-00091-JLR, the Court ordered Microsoft  
5 to show cause why this case should not be remanded for lack of subject matter jurisdiction, too.  
6 (Dkt. #11). Based on the analysis set forth in the Court’s decision in *Williams*, Microsoft does  
7 not oppose remand of this case to King County Superior Court.
