I, John P. Sheridan, make the following statement based on personal knowledge. I am
the attorney of record for plaintiff Julie M. Atwood.

1. At the time that MSA represented that Ms. Fowler “voluntarily left MSA,” the
company possessed documentation of her EEOC Charge in which she clearly alleged she was
subject to discrimination as early as August 2013; claimed she apprised members of MSA’s
Board “how Frank Armijo/Dave Ruscitto/Todd Beyers ... had unlawfully treated me”; and
claimed she did not leave voluntarily but was “constructively discharged on August 13, 2015.”




