FREEDOM OF INFORMATION ACT AND PRIVACY ACT REQUEST (FOI PA 2017-00103)

You requested pursuant to the Freedom of Information Act (FOIA) records of costs and fees invoiced to the Federal Government for attorneys, staff, consultants and experts who are working to defend the Superior Court of Washington for Benton County Case No. 15-2-01924-4, Julie M. Atwood v. Mission Support Alliance, LLC.
