- I, NADYA ROBINSON, declare that the following statement is true and correct:
 - 1. My name is Nadya Robinson.
- 2. I am over the age of eighteen (18) and competent to make this declaration.
 - 3. I am a resident of Port Angeles in Clallam County, WA.
- 4. I own and operate Common Grounds Café, LLC for the past year and a half.
- 5. I became unemployed in mid-March when Governor Inslee issued the stay-at-home order. I tried to do take-out orders at the café, but it was not panning out—I could not cover the cost of my commercial food orders.
- 6. I applied for unemployment benefits before the café completely shut down, was approved for the PUA, and received my first payment of \$13 for the week ending on March 28th, 2020. \$222 was deducted because I was working part-time. I did not receive any of the PUAC \$600.
- 7. When regular payments, \$235 state + \$600 PUAC) began ESD told us that they believed that I was out of the country. My husband and I sent in messages stating that we were not out of the country. We have been here in Washington the entire time.

- 8. After the week ending March 28, I was paid for each of three weeks through April 18th, 2020, and each week the amount was \$835.
- 9. As of the week ending April 25, 2020, the Employment Security Department (ESD) withheld my weekly check with no explanation each week the payment was listed as "pending."
- 10. I have taken the following actions to address this issue with ESD: The first couple of weeks, I called almost every day. We also sent email queries, It went nowhere and I was put on hold every time. I was getting a message on the phone but was not able to get through to a person or voicemail. Of late, the phone does not even answer. For web messages there used to be a place on the ESD website where it said, "I want too..." and I could choose to send a message. That is gone now.
- 11. Four weeks ago, ESD put a note in my file that standby expired and I needed to be looking for work. I sent in messages stating that I own my own business and did not need to look, and would reopen my business as soon as the Governor lifted restrictions.
- 12. Two weeks ago, ESD said that they could not verify my ID and to send them a scan of social security and either a passport or state ID.. I sent in my passport and social security card. Nothing happened, and each payment remained "pending."

- 13. I have been significantly and adversely affected in the following ways due to my not receiving my unemployment benefits: I lease my café space, including utilities, state and local license fees, taxes, and other payments. I have spent all reserves and now been waiting for eight weeks; and I am not able to pay these bills. My unemployment back pay comes to over \$6,500. My husband's unemployment was also made pending two weeks ago, also with a request for ID, and he is a veteran so he sent his passport and his discharge DD-214 and he too is still pending. So now there is no income at all. I also have not been able to contribute to the household bills for two months, and we have mortgage and utility and food payments. This missing money is a lot when there is no other income.
- 14. On a scale of 1-10 my level of fear and stress is a 9. The most stressful thing is that I don't understand why I haven't been paid for eight weeks. I cannot reach them to find out why my payments are pending. I cannot fix it. If they could please explain why they are doing this, it would be a little bit better—but no explanation is completely unfair. I would like to know when they are going to pay me. I believe this deposition should get ESD's attention and they may remember. As a Russian immigrant, I believed that America is better than Russian

bureaucracy. If this happened in Russia, I would not be surprised, but I believed that America has a higher standard.

I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct to the best of my knowledge.
