- I, McKeezi Taylor Barraza, make the following statement based on personal knowledge.
 - 1. On June 6th, one day after the lawsuit was filed with the
 Washington Supreme Court, my ID verification adjudication date
 changed from May 27th to June 6th. Later that evening, the
 adjudication date disappeared completely and my
 pending status showed "processing" for May 30th. On June 7th, the
 May 30th claim moved from "processing" to "paid." On June 9th,
 the payment was issued to my bank account. Although I was paid
 for the week of May 30th, I still have not been paid for the weeks
 of March 28th and March 21st. Those claims still show as
 "pending" with an adjudication date of May 26th which makes me
 question ESD's adjudication process because these claims address
 issues from back in March. Exhibit 8.
 - 2. On June 7th, I filed my claim for the upcoming week. Immediately the claim showed up as Processing-Web. I assumed that it would eventually turn to "paid" in a day or two which was common with my past claims. On June 9th, the claim turned back to "pending" with an adjudication date of June 6th. I was unsure what the issue was this time, so I clicked the upload documents tab and it was

asking me to submit my ID verification documents again. I was beyond anxious and stressed out by this message because ESD had just verified my identification on June 6th and processed payment from the previous week which was held up due to the ID verification processing. I immediately reached out to my lawyer to address this issue and I checked the ESD Facebook page to see if others were dealing with a similar issue. I found out that I was among many who were being asked to submit identification documents again and that our claims for June 6th were not being processed but were once again being held up for ID verification with no timeline for when we would be paid. I also never received notice of having to submit my identification documents like I had the first go-around. Rather, I had to click through all the tabs in the e-service portal to find out what the issue was this time.

3. On June l0th, I was able to finally get a hold of an agent at ESD after calling 68 times between two separate numbers. I asked her what was going on with my claim for June 6th and why it was pending for ID verification again after I had already submitted the requested documentation two weeks prior and was verified on June 6th. She told me it was a glitch in their computer system and to

ignore the pending issue. She said it should go from "pending" to "paid" in a couple of days. I thanked her for the information and told her I would continue to check for updates. On June 4th, I filed another claim for weekly benefits. After one day of processing, the claim showed up as pending due to ID verification. It is June 22nd and I have 4 weeks of pending claims now with no payments sent to my checking account. I have tried every day to contact an ESD agent to explain what the holdup is.

- 4. My identity was verified and approved on June 6th, yet now I have 2 more weeks of claims pending due to another ID verification request. On June 21st, I filed another weekly claim and as of now it is still processing. My adjudication date for all pending claims changed from June 9th to June 17th, and I am still unsure what is happening behind the scenes.
- 5. At this time, I am ready and available to begin working as a barback at Japonessa Seattle, LLC. The bar manager told me my start date could be as late as July or early August due to the fact that they are limited in serving customers in the bar area. I am also unable to be around any large grouping of people due to the fact that my roommate is pregnant and vulnerable to

- getting Covid-19. Due to this fact, the bar manager informed me to continue filing claims with ESD until further notice.
- 6. The glitches, inability to reach an agent, lack of transparency and communication with any sort of pending issue has caused an incredible amount of stress and anxiety in my life. As a transgender male, I was unable to afford my hormone treatment and I had to find a temporary living situation that would allow me to afford my basic needs.
- 7. All I ask the court to do in this matter is to request ESD to do their job by processing our claims in a timely and consistent manner (cannot hold pay longer than 7 days) and to be proactive in communicating with each claimant regarding pending issues.

I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct to the best of my knowledge.
