Comments concerning the candidate's teaching and service are not being requested and are not necessarily helpful unless the reviewer has information on these topics not available to campus reviewers. Please note that we are not asking you to indicate whether the candidate would receive tenure and/or promotion at your institution.

In your letter, please indicate whether you know the candidate and if so, for how long and in what capacity. Please discuss your view, based upon your assessment of the candidate's scholarship, of the significance, independence, and promise of the candidate's work. Additionally, please estimate what you believe to be the impact of the candidate's scholarship on her field. It would be helpful if you could compare Dr. Marshall's scholarly accomplishments with those of other scholars you know in the candidate's field at similar points in their careers.

The University is committed to protecting the confidentiality of external reviewers and the names of reviewers. Unless required as part of legal action to divulge the names of reviewers, your identity will be kept confidential.
