WHISTLEBLOWER INVESTIGATION REPORT

Assertions and results

Our Office received a whistleblower complaint asserting a Department of Social and Health Services employee used state resources for the benefit of an outside business.

We investigated two assertions and found no reasonable cause to believe an improper governmental action occurred.

About the Investigation

Assertion 1: An employee at the Department of Social and Health Services used state resources for the benefit of an outside business.

Our Office obtained the subject's hard drive and email folders and reviewed the data retrieved.

We reviewed the subject's Internet browsing activity, documents, and email folders from November 2013 through November 2014. We found no evidence the subject used her work computer for her outside business.

Assertion 2: An employee at the Department of Social and Health Services used her position to obtain clients for her outside business.

We found no evidence the subject used her position to obtain clients for her outside business.

WHISTLEBLOWER INVESTIGATION CRITERIA

We came to our determination in this investigation by evaluating the facts against the criteria below:

Assertion 1:

RCW 42.52.160 - Use of persons, money, or property for private gain.

(1) No state officer or state employee may employ or use any person, money, or property under the officer's or employee's official control or direction, or in his or her official custody, for the private benefit or gain of the officer, employee, or another.

WAC 292-110-010 - Use of state resources.

(5) Prohibited uses:

- (a) Any use for the purpose of conducting an outside business, private employment, or other activities conducted for private financial gain;
- (b) Any use for the purpose of supporting, promoting the interests of, or soliciting for an outside organization or group, including, but not limited to, a private business, or a political party, or supporting, promoting the interests of, or soliciting for a nonprofit organization unless provided for by law or authorized by an agency head or designee;
- (e) Any use related to conduct that is prohibited by a federal or state law or rule, or a state agency policy

Assertion 2:

RCW 42.52.070 - Special privileges.

Except as required to perform duties within the scope of employment, no state officer or state employee may use his or her position to secure special privileges or exemptions for himself or herself, or his or her spouse, child, parents, or other persons.
