We would also like to ask whether or not the actions in question meet the criteria for a reportable incident as defined by <u>34 CFR 668.16</u>?

Our review concluded that staff and faculty members in the department in question offered, and granted, false academic credentials to students with the intent to bolster their credit loads for financial aid purposes. Correspondence and documentation appear to indicate that this practice was systemic throughout the department, and widely communicated to their students. We have extensive email records and source documents indicating that the 2 credit course was offered to students who needed additional credits to get them up to full-time status for financial aid purposes. There was no work associated with the credits, and the course was referred to by students, staff, and faculty using terminology such as "ghost course", a "filler for credits", "space-filler", "credit adder", and "a 2 credit option during Q1 or 2 for interns to basically "pad" their registration to be full time".

Our analysis indicated that these false credentials were awarded to 20 students between winter quarter 2016 and winter quarter 2019. Our financial aid department determined that 9 of these students received over-awards totaling \$4,580 as a direct result of this practice.

- Does this activity constitute *fraud, misrepresentation, conversion or breach of fiduciary responsibility, or other illegal conduct* and therefore reportable per <u>34 CFR 668.16</u>? If not, how would you classify this activity?

- If you do not feel that this activity violates any of these statutes, does our institution have any other obligations under Title IV, of the HEA program?
