**I. STIPULATION**

COMES NOW the parties and state as follows: On June 26, 2015, the Court  
Granted Microsoft's Motion to Dismiss and dismissed Plaintiff's Complaint in its  
entirety. After the Supreme Court issued opinions in *Rose v. Anderson Hay & Grain*, 184  
Wn.2d 268 (2015), *Becker v. Cmty. Health Sys., Inc.*, 184 Wn.2d 252 (2015), and

to reverse the trial court's decision. On February 16, 2016, the Court of Appeals, Division

Superior Court on April 8, 2016.


2 The Court having reviewed the Stipulation of the Parties, and good cause
